General Admission Criteria

1. First priority is given to full-time, continuing, professional or graduate students at the University of California at Davis.
2. Second priority is given to incoming transfer full-time students **only with permission in writing by Student Housing accommodating special needs.**
3. Third priority is given to incoming freshmen **only with permission in writing by Student Housing accommodating special needs.**

Incoming freshmen and incoming transfers (whom would be considered such by transferring to UCD for the fall, winter or spring quarter of the academic year) are not eligible to reside at Primerogrove for the current year but may apply for the following academic year. Exceptions have been granted by Student Housing on a case by case basis for the following reasons:

- Incoming transfer student, 24 yrs or older.
- Disability access reasons.

Income restrictions apply to certain units. Total household income must not exceed low-income and very-low income limits for Yolo County. See office for details.

Application Process

- **A non-refundable processing fee of \$25.00 per application** will be required to accompany each application submitted.
- Payment must be in the form of a cashier's check, money order.
- Please make out payment to **Primerogrove Apartments.**
- Each occupant is required to submit an individual application, accompanied with the processing fee of \$25.00 per application submitted. Please submit applications for the entire household **at the same time.**
